While proximity may vary based on the location of your home, please keep in mind that the closer the comparable, the more likely it will be considered appropriate.</li> <li>Comparable sales should have similar characteristics including the style of the home, size of the lot, room/bedroom/bathroom count, age, condition, and quality of construction.</li> </ul>
